Prior to the end of your initial term, you will receive two advance written notifications from us. The Initial Notice will be sent to you 45 to 60 days prior to the expiration of this Agreement and the second notice will be sent to you no less than 30 days prior to the expiration of this Agreement. These notifications will explain your renewal options going forward. If you fail to respond to these notifications, you agree that this Agreement can be converted to a renewal agreement that will not include any cancellation/early termination fees. |
